

FTSE4GOOD ENVIRONMENTAL LEADERS EUROPE 40 INDEX

FTSE4Good Environmental Leaders Europe 40 Index is designed to identify European companies with leading environmental practices. These are the companies that are doing more to manage their environmental risks and impacts whilst reducing their environmental footprint.

The index is constructed by taking all European companies in the FTSE4Good Index Series that have obtained the 'best practice' environmental rating of 5, ranking them by full market capitalisation, and then selecting the top 40 to be included in the index.

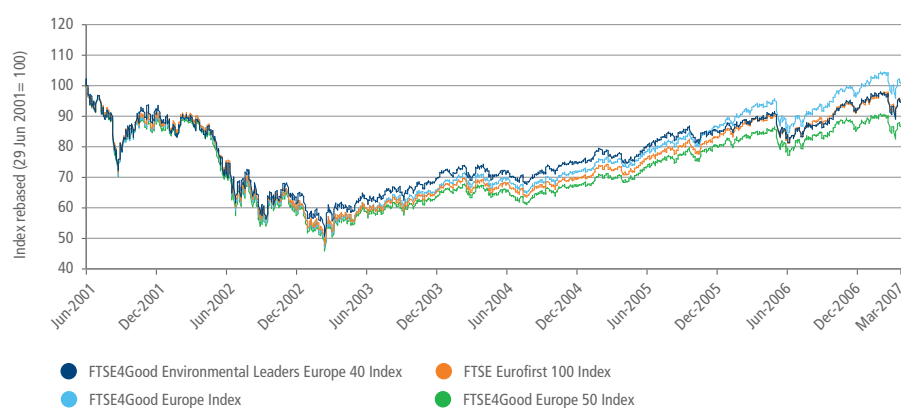
- Index governance is overseen by the independent FTSE4Good Policy Committee, made up of leading global responsible investment market practitioners and experts in the principles and criteria used for determining the social responsibility of corporate entities.
- The data used to assess the constituents is provided by the Ethical Investment Research Service (EIRIS) and its network of international partners.
- Stocks are free-float weighted to ensure that only the investable opportunity set is included within the index
- Capital and total return indices are available for this index
- The series is calculated in accordance with the Industry Classification Benchmark (ICB), a global standard developed in partnership with Dow Jones Indexes
- The index is designed for the creation of derivatives, index tracking funds and ETFs
- Stocks are free-float weighted to ensure that only the investable opportunity set is included within the indices
- Stocks are liquidity screened to ensure that the index is tradable
- Capital and total return indices are available within this series
