## INDEX DESCRIPTION

- The FTSE ASFA Australia Index Series has been created to provide investors a series of tax-adjusted and non-tax adjusted indices for a more accurate representation of performance. In particular:
  - **To provide a more accurate measurement of performance** by taking into account the differing tax positions of investors
  - **A better representation of the market** by not fixing the constituents to allow the indices to expand and contract with the market
  - **Provide investors with a comprehensive and complementary set of indices** which measure the performance of the major capital segments of the Australian market.
