The FTSE ET50 Index (Environmental Technology 50 Index) has been designed to provide investors with a benchmark for environmental technology investments. It is a global index and will include only companies that have a core business in the development and operation of environmental technologies. The index will comprise the 50 largest pure play environmental technology companies by investable market capitalisation worldwide.
