INDEX SPECIFICATION

INDEX DESCRIPTION

- The FTSE Global Wealth Allocation (GWA) Index Series weights constituents of the FTSE All-Share Index and the FTSE All-World Index according to the constituent's ability to create shareholder wealth measured by net income, cash flow and book value. The FTSE GWA Index Series is not market capitalisation weighted but each constituent weight is based upon its ability to create wealth.
