The FTSE NASDAQ DUBAI Shariah Index Series is the result of a joint initiative between FTSE and the NASDAQ DUBAI to create a Shariah compliant index series for the Gulf Cooperation Council (GCC) region for both GCC and international investors. Initially, the index series will consist of 2 tradable indices:

- FTSE NASDAQ DUBAI Qatar 10 Shariah Index
- FTSE NASDAQ DUBAI Kuwait 15 Shariah Index
