

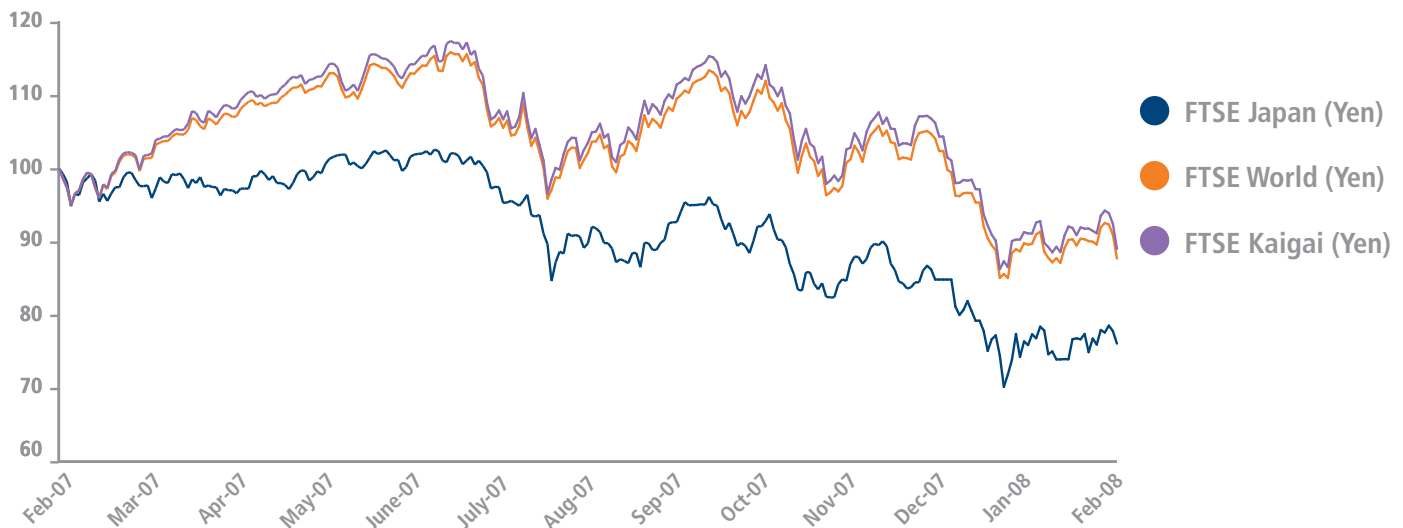
FTSE JAPAN INDEX

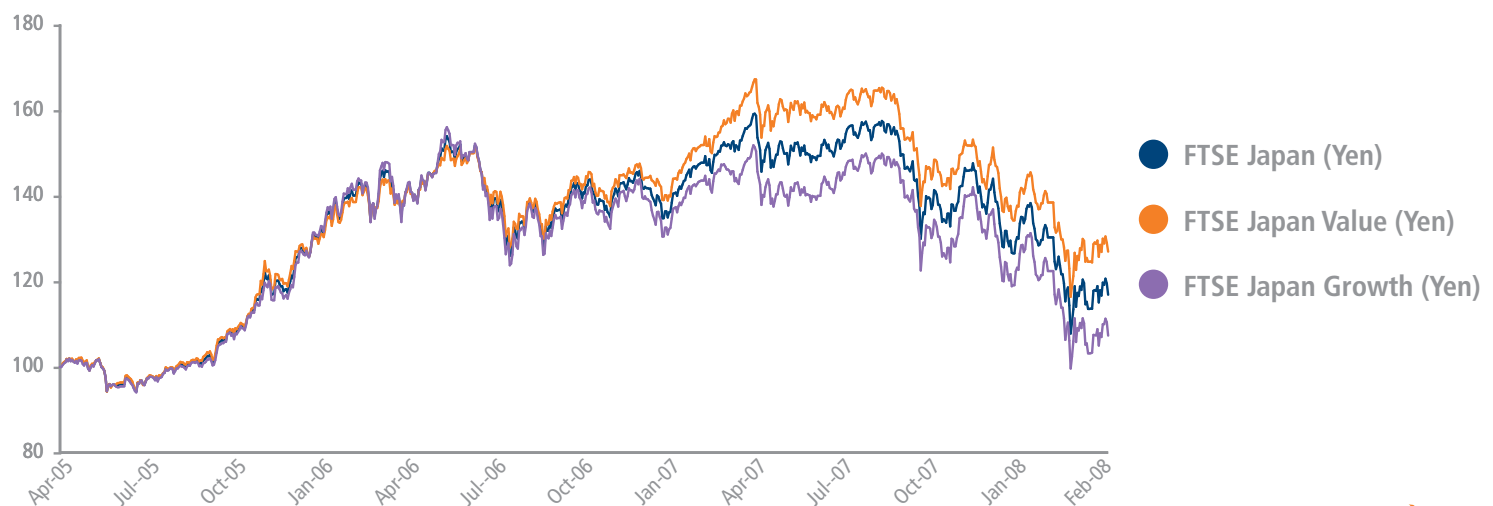
